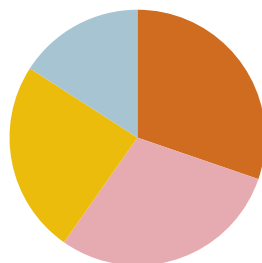
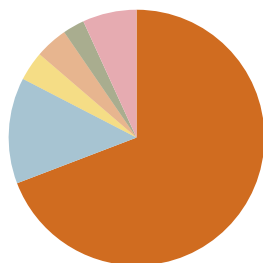

Consumer Alpha Definition:

Infusive defines Consumer Alpha as a company's superior financial performance that is the direct result of products or services that meet basic physical and psychological human needs. Perennial demand for these products reflects a human emotional pursuit for pleasure, joy, and happiness that Infusive expects to last as long as human nature endures."

Alpha Definition:

Alpha refers to the active return on an investment, as measured by the performance of that investment compared with a suitable market index. For example, an alpha of 1% means the investment's return on investment over a selected period of time was 1% better than the market during that same period; a negative alpha means the investment underperformed the market.

Basis Points Definition: 1 basis point equals 1/100th of 1%.
